Employee Payroll Deductions Frequently Asked Questions

What is the Employee Giving Campaign?

While donations can be made throughout the year to the Foundation, our Employee Giving Campaign encourages Atlantic Cape faculty and staff to make contributions through payroll deductions that provide critical financial support to students pursuing a college education at Atlantic Cape Community College.

Why should I make a gift to the Foundation in support of the Employee Giving Campaign?

Employees have asked for a convenient way to give to the Foundation for students in need through a payroll deduction. Now, we have made it easier to support opportunities for our neediest students. Also, it is important for our community and corporate sponsors to know that our employees support the mission of the Foundation and are "all in" for student success.

How much does the Foundation give to scholarships and the college?

In Giving Year 2022, the Foundation awarded 696 scholarships totaling \$634,633! In addition, the Foundation raised \$12,850 for emergency funds, \$35,000 in direct support to the college and \$5,658 for the campus food pantry.

How do I make a gift?

Complete the Employee Payroll Deduction Form (also available online at <u>atlanticcape.edu/give</u> or in the Human Resources Office) and select \$5, \$10, \$19.24 or \$22.73 (a deduction of \$5 per pay for 26 pay periods can turn into \$130 in the span of 1 year!!).

How does my donation help students and can I specify how my dollars are spent?

Each year employee donations contribute to student success by helping to fund scholarships, Alumni Association activities, athletic programs and the College's highest philanthropic priorities like providing student emergency assistance and the food pantry. Gifts made to the area of greatest need allow college leadership to direct funding to where it's needed most, however employees may designate their donation(s) to any existing Foundation initiatives.

How will I be recognized for my gift?

Your name will be included as a donor in Foundation publications unless you choose to opt out and remain anonymous.



How will my donation deduction appear on my paycheck?

Donations to the Foundation will appear on your paycheck with the Code: ACFD.

Do I need to enroll each year?

No, once you are enrolled in the Employee Giving Campaign, your deduction will be ongoing unless you contact Human Resources to stop the deduction.

Are my contributions through payroll deductions tax-deductible?

Yes, contributions to the Atlantic Cape Foundation are tax-deductible. The Foundation will provide you with a letter for tax purposes.

What is the Buccaneer's Giving Society?

The Buccaneer's Giving Society is comprised of Atlantic Cape employees who donate \$500 or more in a single year. That breaks down to \$19.24 per pay for 12-month employees OR \$22.73 per pay for 10-month employees during the year.

Employee Giving Campaign donors at this level, at the completion of each year, may choose to establish a scholarship that will remain as long as you contribute to the fund.

Each year, this group of employee donors will get together for an appreciation gathering to celebrate the Buccaneer's Giving Society with Dr. Gaba, the Advancement Office staff and Foundation Board Members.
