#### X. REGULAR RESOLUTIONS

**Res.** #2 FY23 Draft Financial Statement for twelve months ended June 30, 2023 as of September 11, 2023.

- Trustee Dawson stated the following:
  - O As of this draft, the College has earned 100.08% of budgeted revenues and expended 99.98% of budgeted expenditures. There is no change in revenue from the last draft report. Expenses increased \$44,000 mainly due to payment of encumbrances. The final PERS adjustment is still pending. The fiscal year closing is in process, and the net margin will be determined once the final adjustments are complete.
- Trustee Castillo motioned to approve Resolution #2; Trustee Money seconded. Motion carried.

Res. #31 FY24 Financial Statement for three months ended September 30, 2023.

- Trustee Dawson stated the following:
  - O As of September 30, 2023, the College has earned 43.92% of budgeted revenues and expended 29.24% of budgeted expenditures. Fall credit enrollment is down 5% from budget, or a shortfall of \$476,000. Despite this shortfall, total revenue is up 7.6% compared to the prior fiscal year. State appropriations are \$350,000 higher than the prior year, and interest income is higher by \$168,000. The increase in State appropriations and other revenue will help mitigate the tuition and fee shortfall.
  - o For prior year comparisons, a timing difference exists in payroll expense for faculty as their first pay in FY24 is in September, versus August in FY23.
- Trustee Money motioned to approve Resolution #31; Trustee Nguyen seconded. Motion carried.

And thank you to our sponsors, including Ocean Shores, IBEW, Kisby Shores, Cooper Levinson, Trustee Clemans, the Bank of Elmer and more than 20 other sponsors for supporting this fundraising event.
